## **MINUTES**

**Agenda Item:** Approval of the Meeting Minutes from 4/5/23 Meeting **Presenter:** Kelly Vernon

## Discussion:

The meeting was called to order by Chief Vernon at 12:19 p.m. A quorum of the committee members was not present. The approval of the 4/5/23 meeting minutes was postponed to the next meeting date (April 3, 2024) due to the need for a quorum. The meeting minutes from today's meeting on 10/4/23 will also be placed on the next Agenda for approval. Joe (Joseph) Andrade introduced himself as the new Principal of the Juvenile Detention Facility School.

**Agenda Item:** Updates from Probation on Program **Presenter:** Kelly Vernon

**Discussion:** Chief Vernon provided a brief overview of the current program status, materials, equipment, furnishings orders, and the progress of the capital improvements projects underway at the Juvenile Detention Facility (JDF). There are currently (10) SYTF (Secure Youth Treatment Facility) youth at JDF, and

there were (5) youths who returned from DJJ (Department of Juvenile Justice). The capital improvement projects at JDF started in August. The facility is being re-painted, and the de-escalation room furniture has been ordered. The Regional Hub Agreement with Fresno County is being finalized. The Board approved the Phoenix Transitional Housing Plus Agreement to provide transitional residential units for the SYTF youth participating in the Step-Down program and for youth committed to the Local Custodial program.

## **Questions:**

Joseph Hamilton inquired whether it was necessary to have a transitional home at this point instead of subcontracting to a services provider. Joseph Hamilton also inquired about what a de-escalation room is and its purpose at the Juvenile Detention Facility. Chief Vernon stated that the department would like to track the progress of the contract with Phoenix Transitional Housing Plus and determine the success rate for our youth. Also, Chief Vernon mentioned that the purpose of the de-escalation room is to address short-term trauma needs for our youth, and pictures of the room are available in the SB 823 plan on the OYCR's site if anyone is interested in viewing it.

## **Further Action Items:**

The next biannual meeting is scheduled for April 3, 2024.
